## **ABC Licensing Portal Services Overview**

Kentucky Alcoholic Beverage Control (ABC) has moved to a fully digital license and renewal application process on the Salesforce platform. The ABC Licensing Portal will be used to review, approve and deny applications per local ordinances. Visit the Kentucky Alcoholic Beverage Control (ABC) Portal at







7. Local ABC Admin Login: If you are a Local ABC Admin, you will need to login to access applications





pending your approval.

- 8. **Lookup:** Run a quick search for license(s) of all active alcohol licensees in Kentucky. *Login is not required.*
- 9. **Reports:** Generate reports to view data for newly licensed businesses, renewed licenses, licenses that did not renew, etc.
- 10. **Brand Registration:** The Department uses an online brand registration system known as Kentucky PRO (Product Registry Online) to register brands sold in Kentucky. This is only applicable for producers/suppliers and wholesalers/distributors. *Click on the links to be directed to alternative sites.*
- 11. **Quota Package Availability:** Licenses to sell liquor by the package are limited in number based on your county or city's population. This link will give you information on whether any licenses are currently available in your business's location. *Login is not required.*
- 12. Complaints: Report a suspected violation to ABC Enforcement. Login is not required.
- 13. FAQs: Click View FAQs to view the ABC Licensing Portal resources and information regarding licensing and application questions.
